Department of Massachusetts Sons of AMVETS State Convention-Sturbridge Host Hotel May 31, 2003

1st Vice Commander David Spencer called the Convention to order at 12:32pm. 1st Vice Commander Spencer made the announcement that Commander William Barry did not feel well and that he would be running the meeting until Commander Barry could resume his duties. The Commander will remain on the floor as long as he is able. 1st Vice Commander Spencer read the Invocation. Acting Provost Marshal Joe Crump led the Convention in the Pledge of Allegiance. 1st Vice Commander Spencer led the Convention in the Reading of the Sons Preamble.

1st Vice Commander Spencer turned the gavel over to 2nd Vice Commander Michael Bruno so that he could finish the credentials report.

Roll Call of Officers was done by 2nd Vice Commander Bruno.

1st Vice Commander Spencer returned to the podium and relieved 2nd Vice Commander Bruno.

1st Vice Commander Spencer asked the delegates to bear with him during the reading of the credentials report, and to have 1 member of each delegation to confirm the number of delegates on the floor.

31 Delegates are Present excluding the Commander (he votes only during elections). A majority vote will be 16, 21 will be 2/3rds vote.-Confirmed

1st Vice Commander Spencer called for a Moment of Silence for the 3 members who passed away during the past year. Their names are: Thomas "TJ" Rosenquist (Squadron 79), Kevin Stangle (Squadron 1980), and Neal Mael (Squadron 495).

1st Vice Commander Spencer called upon Judge Advocate Clifford Kaizer to read the Convention rules.

Judge Advocate Kaizer read the Convention Rules and made corrections based on the Uniform Department Constitution and By-Laws. Delegate Counts are one Delegate and one Alternate Delegate for the first eight (8) members, and one Delegate and one Alternate Delegate for each additional five (5) members or the major fraction thereof, as recorded by the State 1st Vice Commander 30 days prior to the Convention. National Commander David Helmuth explained that the changes were approved at the National Convention last year.

1st Vice Commander recognized the National Commander from Massachusetts, David R. Helmuth, PDC, who is also the Immediate Past Department Commander.

Since the last SEC meeting I went to Bourne National Cemetery, as well as Off-Station Parties in Marlboro and Natick. We also at this time have two new Squadrons and 1 Squadron on the way. The new Squadrons are Marshfield 1996 and Stoughton 1977. The Delegation from 1977 is in the back and I'd like your recognition for them please. Clinton 19 is in the process of filling out their Charter Application.

Guest-Guy Massa, PDC

AMVETS PDC Guy Massa came onto the Convention Floor. PDC Massa thanked the Sons for supporting one of his projects this year, the Walk-a-thon, held in Winthrop. Three Sons came out to help and the largest pile of money was turned in by a Son of AMVETS. \$1,248 was raised for AMVETS, \$428 for the Ladies Auxiliary, and \$324 for the Sons. Commander Massa presented a check for \$324 to the Sons of AMVETS to be used however we see fit.

We were also informed that there would be another road race in April.

PDC Massa also handed out flyers for a USO Fatigue Party on Friday, June 27th from 7-11pm at Winthrop Post 48. A donation of \$2 is due at the door. There will raffles, etc.

Presentations of Awards

As Commander Barry could not be present, 1st Vice Commander Spencer presented the Commander's Award. The 2002-2003 Commander's Award was given to Al Gentile. He could not be present so the Award was presented to Squadron 79 Commander Cliff Kaizer.

It was announced that the Commander and 1st Vice decided to split the membership into two categories. Division 1 would consist of the four largest Squadrons, and Division 2 would consist of the four smallest Squadrons. The Division II membership award was won by Squadron 51, on the strength of more than 200% membership, and renewing all 2002 members except for the two who are now in AMVETS. No one was on hand to accept the award, so this will be presented to their AMVETS delegation on the AMVETS floor tomorrow. The Division I membership award was won by Squadron 495 on the strength of 125% membership. This award was accepted by Squadron 495 Commander Joe Crump.

1st Vice Commander Spencer also gave out the following certificates: Exceeding 100% membership-Roslindale Squadron 1 Exceeding 100% membership-Randolph Squadron 51 Exceeding 100% membership-Three Rivers Squadron 74 Exceeding 100% membership-Natick Squadron 79 Exceeding 100% membership-Millis Squadron 495 Exceeding 100% membership-Marlboro Squadron 1980 Largest Squadron in Massachusetts-Roslindale Squadron 1 Most New Members-Natick Squadron 79

The Programs Award was presented by the 2nd Vice Commander to Hudson Squadron 208

Unfinished Business

Judge Advocate Kaizer wished to address the Christmas Fund. This was addressed by Finance Officer Flanigan. So far he has received a total of \$1,739.81. Judge Advocate Kaizer elaborated on the use of the funds. The funds will be used to place scooters in each VA facility. A 50/50 pool was started. 50% goes to the Scooters, 50% goes to cash prizes.

There was no further unfinished business.

New Business

 2^{nd} Vice Commander Bruno asked that we earmark the \$230 he personally raised for the walk-a-thon to go to the Scooter fund unless the Department has a better use for that money.

 2^{nd} Vice Commander Bruno presented a check to National Commander Helmuth from Squadron 1 towards the National Scooter Fund in the amount of \$50.

Harry Dascoli (Marlboro 1980)-asked about the Lifetime Membership Procedures in regards to the way cards are issued, specifically that they be issued through the Squadron as opposed to sending them directly to the members. He was advised that all Life Membership issues must go through National, as all life membership are handled only through National. It was suggested that perhaps the National Commander could bring this to the National Life Membership Committee to address. National Commander Helmuth mentioned that all life memberships are to be sent to National directly by the member purchasing the Life Membership. 1st Vice Commander Spencer mentioned that the 1st Vice does not get a copy of the life member form from National with the number

on it. There was also not a Life member report by name at the NEC for perusal. He had to specifically request one from National.

There was no further New Business.

1st Vice Commander Spencer called for a 15 minute recess.

The meeting was called back to order at 1:30pm.

National Commander addressed the Convention Body. He thanked all the Sons in Massachusetts for their support. He mentioned the Scooters for Vets Program. The object is to place one in all 198 VA facilities in the US at \$1,500 each. The main thing is to donate to the cause by the Departments. The motto this year is "No Boundaries," which we don't have. So far we have placed 30 scooters across the country. We just received pledges for another \$14,000 this week alone. The system is working. They are placing their second scooter in each facility. There will be a new Uniform Department Constitution and By-Laws on the floor at the National Convention.

Joe Crump (Squadron 495) there is a problem with the online forms: When you type in "MA" onto many forms, it does not fit, and the "A" disappears. Commander Helmuth will discuss this with the National Webmaster.

1st Vice Commander Spencer asked the Convention to recognize the efforts of Joe Crump from Squadron 495. He helped set up the Convention room, and set up the flags, with no questions asked. He helped out with the Flag truck as well as a number of other things today.

The Convention asked for an update on Commander Barry. We were informed by National Commander Helmuth that Commander Barry was expected to be back on the floor in about 20 minutes.

1st Vice Commander Spencer presented Squadron 1977's Charter to their Squadron Commander, James Foren.

1st Vice Commander Spencer informed the Department that the Squadron 208 Color Guard would be attending the National Convention. As they would likely exceed their allowed delegation size at the National Convention, he asked the Convention to make him the Department Delegate. This was allowed by the Convention by Unanimous Consent.
