Unfinished Business

A. 2005 Membership Drive-The Question was raised as to whether any Squadrons have not submitted at least their 1st 8 members for 2005 at this time. It was found that Chicopee, Clinton, Randolph, Three Rivers have not. There was a question as to whether membership was being sent to last year's 1st Vice, Harry Dascoli. Per the Constitution and By-laws, each

Squadron not in compliance must be sent a letter informing them that they are in membership suspension. They only need to send in their membership by February 15th to avoid Charter Suspension.

3rd Vice Commander Boothby wanted to thank the Sons for all they did during the holiday season. The AMVETS will be doing a reverse raffle. The funds raised will be for VAVS funds during the holidays. Tickets are \$10 each, 300 tickets.

- B. Scooters Update-We have placed the scooters at Brockton and Bedford. The Commander will be bringing the Scooter to Northampton on January 18th. He tried to get it as early or late in the day as possible to allow as many people to go as possible, however the best he could do was 4:30pm. He will be leaving Hudson at 2:30pm. If you would like to go, let him know ASAP.
- C. Newsletter-There was discussion on the Sons State Newsletter. It was sent out at the beginning of the month. It will be sent out every other month for the time being. All State Officers need to submit something for it by the 17th of the month prior to it going out. If there are no submissions for the next one, the Commander will cease doing it. For the time being, the mailing list will be as follows: all State Officers, all Past Sons State Commanders, all Squadron Commanders, AMVETS State Headquarters, AMVETS State Commander, Auxiliary President, National Sons Headquarters, and all Posts with a Squadron.
- D. Deep Sea Fishing Trip-After the last Committee Meeting, the chairman contacted Yankee Fleet again, to find a group rate since we cannot commit to a full charter. He will try to make arrangements for a group rate with another Fleet, but most are still closed for the season. The Committee will continue to look around.
- E. Brockton Bowling Alleys Update-No further information at this time.

New Business

A. National Executive Committeeman-National is now partially covering NEC men for Fall NEC, Spring NEC and Convention. They will get 2 nights/2 per diems for Fall NEC, and 4 nights and 4 per diems each for Spring NEC and Convention. They will still need to provide their own transportation. Since there is now significant financial coverage for the NEC man, The Commander will be resigning as NEC man and appointing a new NEC man. He has already talked to several candidates about this, and the job responsibilities. The Commander appointed Henry Shilo to the position of NEC man. There was some discussion around this appointment. The meeting moved into an executive session of the Executive Board. Upon return from the executive session, the following motion was made.

MOTION: to table the appointment of the NEC man to a special meeting by Judge Advocate Kaizer, seconded by 1st Vice Commander Bruno. **MOTION PASSES**

The Commander made an announcement that there would be a special meeting on January 25th to handle this issue, and that coming out of that meeting there WOULD be a new NEC man for Massachusetts. Pending that meeting, he withdrew his resignation from the office of NEC man.

- B. Testimonials-Tom Glenn's Testimonial is Sunday, April 3rd from 1-5pm. Betty Shortsleeve is Saturday April 30th, from 6-10pm. Bob Grose's is April 9th from 6 to 10pm in Ohio. The Commander is not having a Testimonial, but in order to hold the date, his sister is putting together a Roast. It will be held at Natick the night before March SEC. He would like to see some of the Sons at Tom and Betty's Testimonials.
- C. State Commander's Roast-The date of the Roast will be March 19 (the night before March SEC). It will be at Natick 79 to accommodate people going to the SEC the next day. There will be rooms available at the Hampton Inn on Friday and Saturday night at a room rate of \$89.99, plus tax (9.75%). The Commander has invited the National Commander for a visit that weekend. If he (or his designee) is coming, he is planning to bring them to some different places around the State. The rough itinerary is to have them over to Hudson 208 on Friday night, to bring him either out west or to Haverhill for the morning/early afternoon on Saturday, then to have him at Natick for the Testimonial that night and the SEC meeting the next morning before bringing them back to the airport to go home. As far as complimentary tickets, the usual required ones are being put aside. Last year, nothing was asked of the Department to put this on. This year, the Commander would like the Department to pay for the tickets for the officers if we have funds available. Then the officers only have to pay for their escort. Just so that there is no confusion, this does not mean that the tickets are going to be comped, it means that the Department will pay for the tickets into the Testimonial Fund at the normal rate. The Commander's sister is in charge of the Roast, and she has set up a budget based on 34 tickets sold, with 16 complimentary tickets, for a total of 50 people.

MOTION: for the Department to purchase a Ticket to the Commander's Roast for each Officer, the Immediate Past Commander and Coordinators by Judge Advocate Kaizer, seconded by 1st Vice Commander Bruno. **MOTION PASSES**

Commander Glenn wanted to thank the Sons for the great work with the Scooters. He wanted to make sure the Sons Squadron at Randolph was recognized for their efforts in raising funds for the Brockton VA. He expressed his opinion that the Auxiliary and the Sons were not subordinate to the AMVETS, but rather equal partners with AMVETS. The Passion Plunge is on February 12th, please consider plunging with us. He also wanted to make sure that we heard about the oral history project. The SDC will be coming up in May, but there is no date set at this time.

Guest: AMVETS Convention Corporation President Al Temple, PDC

PDC Temple informed the Sons about the State Commander's Testimonial, which will be on April 3rd from 2pm. \$30pp. See Tom Davitt or Jim Blake. It will be at the Vittori Rocci Post (Italian American War Veterans Post) in Beverly, MA. Directions will be in the Bulletin. Commander Spencer asked about possibly getting back into the room we used to have at Convention (Seminar Room). PDC Temple will look into it.

- D. National VAVS Grants Applications-\$100 grants are available from National to each facility. It can be requested by the VAVS Rep for each facility once per year. It can only be used for things of direct benefit to the Veterans (i.e. not personal expenses of the Reps & Deps, but on food, games, parties, etc.). Please note that there is a special report that must be returned to the National VAVS Coordinator within 30 days of the granting of the funds.
- E. VAVS Project-Past National Commander's Project. While at the NEC this past December, the Commander got to talking to PNC Summerall regarding his project from last year. It was Charlie's goal to get his monies spread out as far as possible. He asked the Commander as well as other Departments to get requests in for the funds ASAP. Since Ohio had made 2 requests, and had a Squadron also requesting funds, Commander Spencer decided to put in a request for \$500.00 from the fund. We got the full amount requested. Commander Spencer would like to add the \$385 that he raised since the last meeting to that, and would like the Department to kick in \$115 from the general fund to get this to a full \$1,000.00. He would also like to put requests out to each Squadron for \$100 to add to this project. We could hit \$2000 if all Squadrons give at least \$100.00. He will then go to Wal*mart and see what they will do for us and we can get as much underwear as possible.

MOTION: for the Department to add \$115 from the VAVS fund to the \$885 raised by the Commander since the last meeting for the purchase of underwear, etc. by Judge Advocate Kaizer, seconded by 1st Vice Commander Bruno. **MOTION PASSES**

F. The VAVS Coordinator submitted a bill reflecting unauthorized expenses he incurred in printing 30 VAVS Representative Handbooks.

MOTION: for the Department to reimburse Squadron 79 in the amount of \$173.20 for the VAVS Representative Handbooks by 1st Vice Commander Bruno, seconded by 2nd Vice Commander Shilo. **MOTION PASSES**

Commander Spencer asked the Judge Advocate (and all officers) that he not spend more money without the approval of the Executive Committee or of the Commander.

- G. 2005-6 State Offices-At the end of the next meeting, the Commander will open up the floor to anyone who would like to make an announcement that he is running for an office and what he is running for at Convention. This is not nominations.
- H. State CBL Committee-Commander Spencer asked the Judge Advocate to think about possible members for a CBL Committee. Members of the Committee should represent the Department as much as possible (i.e. avoid multiple members from the same Squadron).

They should also be knowledgeable of Robert's Rules of Order, and the Uniform CBLs. Five members including the Commander and the Judge Advocate should be sufficient to the task

- I. National Convention 2005-This is August 13-20, 2005 in Kansas City, MO. Sons Business will likely be starting 17th, and go through the 20th. A friend of this Department, Mike Mrzlak from Iowa, will be running for National Commander. He has been nothing but supportive of this Department since we formed and first got involved in National, and he is an all-around good guy. We should try to be there to support him if we can.
- J. The Commander announced that he will be running for National Office at the 2005 National Convention. He will likely be running for either National Provost Marshal or National Judge Advocate, depending on what the people currently in those positions are doing and who else might be running.
- K. Randolph will be running a raffle to raise funds for their Past Squadron Commander who is dying. He has no money. He has been given 3-6 months to live. Tickets will be \$5 each.
- L. Last years' State 1st Vice, Harry Dascoli cancer is also out of control. He has been sent home with the morphine drip, and chemotherapy has been stopped. The Immediate Past Commander and Vice Commanders have advised that when and if Harry passes away, the Commander expects the Officers to be at the wake, and hopefully also the funeral.

The Department purchased an alcoholic beverage for the 2nd Vice Commander as today was his birthday.
