I have been having a printer problem. I am unable right now to print new membership cards. When I go to print the cards from the database, my printer disappears every time I try to print a card. I apologize for the delay in getting the cards, but I have been physically unable to buy a new printer. The Commander has been helping me with the printing.

There was some question about the numbers from Natick. The 1<sup>st</sup> Vice Commander will review his numbers and make sure everything is up to date for his next report.

There was also a question about how long checks are taking to clear. The 1<sup>st</sup> Vice stated that all checks received by him prior to this meeting have been given to the Finance Officer.

The Commander addressed a point on membership. There have been a lot of complaints about membership this year. Some of these complaints are very well founded. Some go back to when the Commander was 1<sup>st</sup> Vice. When he was 1<sup>st</sup> Vice, he lived one town over from the Finance Officer. His signature was on the checking account. He had the time physically to process membership on a daily basis. If a Squadron mailed a D&R on Monday, he received it by Wednesday, mailed it back out on Thursday morning and they had it no later than Saturday. Everybody got used to that for 2 years. When Harry was 1<sup>st</sup> Vice last year, he was not working a lot due to his illness. He was processing not everyday but at least every few days. That wasn't that big of a change. This year what has happened is that the 1<sup>st</sup> Vice works 12 hours, often six days a week. This means he is not home 14-15 hours out of the day and spends the other 9 hours sleeping and doing his hygiene. As a result, he's not processing membership every single day and we shouldn't expect that of a 1<sup>st</sup> Vice. The job of the 1<sup>st</sup> Vice on a daily basis is the hardest job outside of Commander. No other job even comes close. In a way the Commander feels responsible for many of the complaints, since he did coddle the Squadrons around their membership.

# National Executive Committeeman's Report

#### **Unfinished Business**

- A. Scooters Update-The final scooter was placed at Northampton, which gave us one at each of the 4 major facilities. We knew pretty early that we weren't going to go with JP due to a VERY low census and that it was becoming a psych unit. This sort of piece of equipment would not be of much use there. We went with the other four facilities in Northampton, Bedford, Brockton and the one placed last year in West Roxbury. That project is now completed successfully. The Commander thanked everyone who helped to raise those funds especially Squadron 79 in Natick who raised the biggest percentage of the money.
- **B. VA Fund Update**-With the \$500 we got from National, the \$385 that the Commander raised at a local BINGO, the \$115 that the State was kicking in brings it up to \$1000. To date, the Commander has received checks from:

- C. 2005 Convention Raffle Update-Money-wise the raffle seems to have gone over very well. We will make a few bucks on this. It was supposed to be drawn today due to not having all of the ticket stubs here. All those who have tickets should send them to the Commander and he will draw it at the next committee meeting (whichever the first one is) that happens and let everyone know who won.
- **D.** Brockton Bowling Alleys Update-We approved \$100 for the Brockton Bowling Alleys at the last meeting. The check was given to Immediate Past Commander Barry for delivery today.
